Fear for safety / Death threats

Amnesty International is concerned for the safety of members of the human rights organization *Asociación Madres de Plaza de Mayo*, Mothers of the Plaza de Mayo Association, who have recently been threatened and intimidated as a result of their work on behalf of the "disappeared".

The threats, made to Hebe Bonafini, the president of the *Asociación Madres de Plaza de Mayo*, were contained in a document sent to the organisation and to the Argentine press, a few days ago. Reportedly the document was issued by the *Alianza Anticomunista Argentina* (AAA), Argentine Anti-Communist Alliance, a former death squad and right wing paramilitary group active in the 1970s which directed organised violence against what could broadly be called the left - students, lawyers, journalists and militant trade unionists. The document, dated October 1999, indicates that the AAA held a recent congress and threatens to take "direct action" if assistance is given to judicial investigations currently underway abroad, into past human rights violations in Argentina.

The return address on the document was that of the Judicial Morgue where, a few days ago, threatening graffiti had been daubed on the walls. It read: "*Muerte a Bonafini y a las viejas*" ("Death to Bonafini and the old women"), "*Muerte a Bonafini y a las viejas de Plaza de Mayo*" ("Death to Bonafini and the old women of the Plaza de Mayo square"), and "*Cárcel a Bonafini*" ("Prison for Bonafini").

#### BACKGROUND INFORMATION

The *Asociación Madres de Plaza de Mayo* is a women's human rights organisation set up to campaign for their "disappeared" relatives. Amnesty International issued another Urgent Action on behalf of its members in October 1999 (see UA 265/99 Argentina, AMR 13/03/99, 6 October 1999 and follow ups) after the association received a threatening phone call and E-mail, and threatening graffiti was daubed on its walls.

The organization has consistently urged the Argentine authorities to clarify the fate and whereabouts of the "disappeared", stating that the victims' relatives have a right for the truth to be made public and for those responsible to be brought to justice.

**FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in Spanish or in your own language:**

- expressing concern for the safety of Hebe Bonafini and other members of the *Asociación Madres de Plaza de Mayo*, who have been threatened, in an apparent attempt to intimidate them;
- calling for a prompt, full and impartial investigation into the threats and intimidation against them, for the results to be made public, and for those responsible to be brought to justice;
- reminding the government of its obligation to clarify the fate and whereabouts of those who "disappeared" during Argentina's military rule and for those responsible to be brought to justice;
- urging the authorities to publicly repudiate all harassment and intimidation of human rights defenders, and to publicly recognize the important contribution that human rights defenders make to the protection of human rights and the promotion of a society which fully respects human rights.
