Amnesty International remains concerned for the safety and well-being of the seven men named above. They are being held on suspicion of involvement in an alleged plot to destabilize Burundi's Transitional Government and to assassinate President Pierre Buyoya and Jean Minani, President of the Transitional National Assembly. Nestor Nimubona is suspected of taking part in violent student protests on 4 November, apparently aimed at bringing Bujumbura to a standstill. The seven men named above who are still in detention were arrested on or around 1 November. None of the men have been charged or are thought to have had access to lawyers.

Nestor Nimubona, Léonidas Ntakaye, Bernard Rutegaka and Jules Gatonga are all held at the *Documentation nationale*, National Intelligence Agency, which reports directly to the Presidency. On 18 December, following protests by Burundian human rights groups and the relatives of the four men, the *Documentation nationale* director (*administrateur général*) granted authorization for the families to meet the detainees. Previously, family members had only been allowed to bring food for their relatives but not to meet them.

Christophe Hicintuka is currently held at the *Police de Sécurité Publique* (PSP), Public Security Police which reports to the Ministry of Interior and National Security. Amnesty International has documented scores of cases of ill-treatment and torture at both the *Documentation nationale* and the PSP. Hilaire Ntahomvukiye and Zénon Nimbona are both currently reportedly receiving medical treatment at Bujumbura's military hospital. Christophe Hicintuka was also briefly hospitalised on 20 November after intervention by human rights groups who visited him at the PSP. He was reportedly suffering from malaria.

Benoit Ndorimana was released without charge on 16 November. Elvis Kazungu, Thierry Ndayishimeye, Innocent Nsabimana and Alexis Ndayishimeye were all also released without charge on 29 November. Elvis Kazungu who was badly ill-treated by gendarmes from the *Bataillon d'Intervention*, Intervention Battalion, following his arrest late at night on 1 November, is continuing to receive medical treatment for his injuries.

He was badly beaten and cannot walk without crutches. He was also beaten on the head and face and one of his eyes damaged, for which he is also receiving medical treatment.

Jean-Baptiste Bagaza, former president of Burundi, who is also accused of involvement in the alleged plot, remains under house arrest in Bujumbura.

**RECOMMENDED ACTION: Please send appeals to arrive as quickly as possible, in French or your own language:**

- expressing concern for the safety of the seven men detained at the National Intelligence Agency and the Public Security Police (please give their names);
- urging the authorities to ensure that the men are protected from torture or ill-treatment in detention;
- calling for them to receive immediate and continued access to their families, lawyers, medical care and human rights and humanitarian organizations;
- urging for the release of any detainee who is not to be charged promptly with a recognizably criminal offence for which there is supporting evidence;
- calling for an investigation into allegations that Elvis Kazungu was ill-treated at the time of his arrest, and for the perpetrators to be promptly to justice.
