Fear of refoulement / Death penalty

ALBANIA/EGYPT      Ahmed Isma'il 'Othman

---

Ahmed Isma'il 'Othman was reportedly arrested on 13 August 1998 in Tirana by the Albanian authorities and is at risk of being *refouled* to Egypt, where he has been sentenced to death *in absentia*. Ahmed Isma'il 'Othman is at imminent risk of execution if he is sent back to Egypt.

Recently, other Egyptians under sentence of death *in absentia* have been forcibly returned to Egypt by the Albanian authorities (see EXTRA 53/98, MDE 12/42/98, 4 August 1998).

**BACKGROUND INFORMATION**

Ahmed Isma'il 'Othman was sentenced to death *in absentia* by the Supreme Military Court in Cairo in March 1994, in the case known as "the attempted assassination of the Prime Minister Dr 'Atef Sidqi". Fifteen people were tried in this case. Nine of them were sentenced to death (four *in absentia*, including Ahmed Isma'il 'Othman), three were sentenced to 15 years' imprisonment, one to five years' imprisonment, and another to three years (*in absentia*). One person was acquitted. Charges against them included plotting to kill the Prime Minister on 25 November 1993, plotting to overthrow the government, possessing explosives and weapons, forging documents and reviving the banned Islamic group known as *Gihad* (Holy Struggle).

Under Egyptian law a sentence passed by a military court *in absentia* is carried out as soon as the the person is arrested or returned to Egypt.

**RECOMMENDED ACTION: Please send faxes/express/airmail letters in Albanian, English or your own language:**

- asking the Albanian Government to clarify the circumstances surrounding Ahmed Isma'il 'Othman's arrest in Tirana on 13 August 1998;
- urging the Albanian Government to clarify whether he is still in detention, and, if so, on what charges;
- urging that he be charged with a recognizably criminal offence or immediately released;
- calling on the Albanian authorities not to return Ahmed Isma'il 'Othman to Egypt, where he is at risk of imminent execution;
- reminding the authorities of Albania's commitment to the Universal Declaration of Human Rights, in particular Article 3: "Everyone has the right to life, liberty and security of person."
