UKRAINE Vitaly GUMENYUK, aged 24

President Leonid Kuchma of Ukraine gave assurances yesterday that he would devote special attention to the case of Vitaly Gumenyuk.

Amnesty International has learned that during the Plenary Session of the Parliamentary Assembly of the Council of Europe of 23 April 1996, Senator Imanol Bolinaga of the Basque Nationalist Party intervened on behalf of Vitaly Gumenyuk and urged President Kuchma to do everything in his power to stop his execution. President Kuchma confirmed that he would look into his case.

In response to previous Urgent Actions on the death penalty in Ukraine, the Ukrainian Embassy in Canada recently issued a statement which confirms that no official legislation to abolish the death penalty has as yet been passed in Ukraine and a moratorium on executions has not been imposed. This is despite the fact that Ukraine, by having joined the Council of Europe on 9 November 1995, has committed itself to impose an immediate moratorium on executions and to abolish the death penalty within three years.

FURTHER RECOMMENDED ACTION: Please send telegrams/faxes/express/airmail letters in English, Ukrainian, Russian or in your own language:

- welcoming President Kuchma's assurances to the Parliamentary Assembly of the Council of Europe to look into Vitaly Gumenyuk's case;
- urging President Kuchma to reverse his decision to refuse clemency to Vitaly Gumenyuk, to stop the execution and to commute all other death sentences that come before him;
- urging the Ukrainian authorities to ensure that, as a member of the Council of Europe, they fully respect all commitments undertaken to impose an immediate moratorium on executions, and to abolish the death penalty within three years.
