Staff and children at the orphanage "Lafanmi Selavi"

Amnesty International is concerned at the continuing intimidation and attacks reported against the orphanage for street boys "Lafanmi Selavi" in Port-au-Prince.

On 13 June at around 4:00am several shots from automatic weapons were reportedly fired in the area near the orphanage. Later, at around 5:00am, a bomb allegedly caused a fire that caused severe material damage to the premises of the "Lafanmi Selavi" orphanage. Fortunately no victims were reported.

On 17 June at about 0:30am several unidentified people were reportedly detected around the building of the orphanage. They were apparently inspecting the orphanage buildings with electric torches. These people left when the alarm system went off but fired several shots in he air before leaving.

On 19 June an anonymous telephone call reportedly warned a worker of the orphanage that "the fire which burnt your premises is only the beginning. It will be worse from now on" ("Le feu qui a brûlé la maison, ce n'etait qu'un début. Cela va être pire maintenant"). A few days later, on the night of 22 to 23 June, four unidentified men wearing civilian clothes and apparently carrying heavy weapons reportedly went to the garden of the house next to the orphanage. According to information received by Amnesty International these men were also inspecting the orphanage's building with electric torches. They then left the house and, once in the street, fired several shots in the air causing panic among the people inside the orphanage building, and left after throwing a large number of stones at its gates.

BACKGROUND INFORMATION

The orphanage "Lafenmi Selavi" was founded by deposed president Jean Bertrand Aristide in 1986 and since the *coup d'Etat* of September 1991 has been the target of numerous violent episodes involving the security forces. On 1 October 1991 17-year-old Jacques Séus Jean Gilles was reportedly killed and five other people wounded in an attack carried out by the security forces against the orphanage. On 20 May 1992 the security forces again reportedly carried out a search in the premises and two days later several shots were apparently fired from a passing car against the orphanage.

Troops violently overthrew the democratically elected government of President Jean-Bertrand Aristide, who took office in Haiti on 7 February 1991, in a coup on the night of 29 to 30 September. Since then Amnesty International has learned of widespread human rights violations committed by the security forces, including a large number of extrajudicial executions, torture and ill-treatment and mass arrests

without warrant. These abuses have been carried out by uniformed security force agents or, on some occasions, by men in civilian clothes ostensibly linked to them.

Children were not spared the violence that followed the coup. They were among the hundreds of victims of extrajudicial execution, arbitrary arrests and ill-treatment. (See Haiti: The Human Rights Tragedy - Human rights violations since the coup, AI Index: AMR 36/03/92 of January 1992)
